

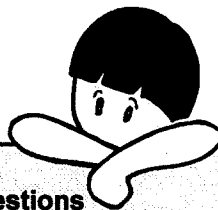
Are You Eligible?

To receive a Professional Advancement for Kids (PAK) Scholarship:

- ✓ You must work with Nevada County children under age six, or their families, or their caretakers.
- ✓ Additionally, you must want to attend a training or conference that will improve your skills while working with children under age six, who have not yet entered kindergarten, or their families, or their caretakers.
- ✓ Additionally, the educational purpose must serve as an outcome identified in the First 5 Nevada County Strategic Plan. Please call our office or check our website for a copy.

Please note:

- ✓ Funds may be awarded to applicants for registration, travel and other expenses related to an educational purpose.
- ✓ Funds may be awarded to applicants who would not otherwise be likely to take advantage of the educational opportunity.
- ✓ Funds will be equitably distributed, and will be granted in a manner that utilizes resources as efficiently as possible.

Professional Advancement for Kids Scholarships



Revised October 3, 2008

Background

Many Nevada County service providers find it difficult to participate in educational opportunities because of geographical separation and/or monetary limitations. First 5 Nevada County recognizes this limitation and would like to help fill the financial gap with the Professional Advancement for Kids (PAK) Scholarships.

Service providers may qualify for a PAK Scholarship related to their work with children under the age of six, or their families/caretakers. These scholarships can cover actual expenses up to \$500 per applicant.

This fund will be awarded on a first come, first served basis, as a limited number of scholarships are available. It is the responsibility of the applicant to prove eligibility and need in the 200 word narrative. Please see the reverse for contact information and feel free to call one of our staff with any questions.

Decisions made by First 5 Nevada County staff on applications can be appealed in writing to the Executive Director within 20 days of notification. The Executive Director will consult with the Commission Chair and their decision is final.

(ESP participants are not eligible for PAK Scholarships).

1. When can I apply?

Applications are accepted any time. Please note processing time in questions 4 and 5.

2. How much money can I apply for?

The maximum scholarship amount is \$500. This can be in advance of an event or as a reimbursement for an event you attended within the last month.

3. What types of training opportunities are eligible for PAK Scholarships?

As long as your training is directly related to your work with children prenatal to age five, or their families, you are eligible for this scholarship program. **It is the responsibility of the applicant to demonstrate why this is an appropriate and important training.**

4. How quickly will my application be processed?

After your application has been received, you will be notified within ten business days whether you have qualified for a scholarship.

5. If my application was approved, when can I expect the money?

After your application is approved, it will take up to 20 days to prepare a check. Therefore, you should apply about a month before you need the check.

6. How often can I apply?

You may receive only one scholarship per fiscal year (July through the following June).
